

# Prince George Golf & Curling Club Annual General Meeting September 22, 1995

The meeting was called to order at 8:10 p.m. by President Betty-June Gair. There were 54 members present, constituting a quorum. President Gair explained the reason for the change of date (ie: a Friday).

#### Review of Minutes

Copies of the minutes were available for review. MOTION: The minutes be accepted as written. (Don Grantham/Al Wells) CARRIED

#### 3. Business Arising from Minutes: Nil

#### 4. Auditor's Report - Stan Mitchell (KMPG)

The Audited Financial Statement for the period ending April 30, 1995 was reviewed. The statement was published in the September issue of the P.G.G. & C.C. Georgian.

Particular items of note and general comments:

i) Page 1 - Combined Balance Sheet

The P.G.G. & C.C. does not depreciate capital assets, although this is standard accounting practice, it was not done historically and will not be started

A significant change was made to this balance sheet in that the "Cash allocated for future capital expenditures" is a new line entry. This is the monthly assessments and will be shown separately.

- ii) Page 5 Notes to combined Financial Statements.
- Curling and golf are presented as combined statements.
- The notes on long-term debt show there is deduction.
- The concession stand is reported in a separate schedule from the restaurant for 1995. The figures for 1994 were changed. The 1994 schedule, published last year will be different in this edition of the financial statement.
  - iii) Page 8 Schedule of Court Operations.
- The net revenue is decreased by about \$10,000. This is mainly due to the competition with UNBC's new facilities.
  - iv) Page 9 Schedule of Curling Operations
- The increased usage and higher curling memberships resulted in an increase in operating contributions of about \$14,000.
  - v) Page 10 Schedule of Golf Operations
- There was an increase in operating contribution of \$26,000 in 1994. This was due to a longer season, increased green fee revenues and higher membership dues.
  - vi) Page 11 Schedule of Restaurant and Lounge
  - Sales were increased; gross profit slightly decreased.
  - vii) Page 12 Schedule of Concession
  - -This is now separate from restaurant/lounge.
  - viii) Page 13 Schedule of Roller Rink
  - Expenses for repairs and maintenance were due to a new roof on the

Excess of revenue \$239,581.

- Q1: What is meant by donation of services in the schedule of capital expenditures? (Ken Dorosh)
- A1: A loader was used in golf course development and the services were donated. (Stanley Mitchell)
  - Q2: Are we taxed on it? (Ken Dorosh)
  - A2: No. (Stanley Mitchell)
  - Q3: Professional fees (Schedule of Administrative Expenses) are signifi-

cantly increased. What is the reason? (Chester Jeffrey)

- A3: An audit was done mid way through the fiscal year, thus the high professional fees. (Stanley Mitchell)
  - O4: Should this occur again? (Chester Jeffrey)
  - A4: No, not anticipated. (Stanley Mitchell)
  - Q5: Did the audit demonstrate any loss of assets? (Chester Jeffrey)
  - A5: No substantial loss. (Stanley Mitchell)
- O6: Staff has the responsibility to ensure a structure with appropriate controls in place. Were there improper controls? (Chester Jeffrey)
- A6: The auditors would have the responsibilities to submit a management letter Re: efficiency of operations if necessary. The auditors found no significant lack of controls. (Stanley Mitchell)
- Q7: Is any qualification present on the audited financial statement? (Chester Jeffrey)
  - A7: No. (Stanley Mitchell)
- Q8: Does the club have adequate insurance coverage to cover significant loss? (Chester Jeffrey)

#### 5. Financial Report - Don Grantham

- For the first four months of the fiscal year commencing May 1, 1995, comparison of expenses vs revenue shows a net profit of approximately \$20,000 to date.
- Golf revenue is increased substantially due to high green fees and member dues.
- The lounge/restaurant revenues are significantly decreased, as are clubhouse expenses
- This should be addressed by the upcoming changes to lounge and restaurant staffing and operations.

#### 6. President's Report - Betty-June Gair

During the past year our club has seen many changes, particularly in staff One of the significant events of the year was the resignation of our General Manager effective April 7, 1995.

Mr. Mathews and the Club entered into a settlement agreement. In respect of that resignation and the terms of it are confidential as required by the agreement. This decision was made in the best interest of the club and its members.

Our club appointed Neil King as acting general manager.

Our first round of applications did not result in a suitable candidate and the board has decided to run a new set of advertisements for the position within a month or so. Neil King has agreed to stay on until the spring if necessary.

Our cook left in August and we recruited a new chef from Vernon who arrived this week. His name is Patrick Murtagh and we know that he will be an asset to the clubhouse and kitchen.

Our maintenance man Cesar Catarino retired and we hired a new jack of all trades Lawrence Doherty who is doing a splendid job.

Our curling coordinator Vera Rohel who has been with our club for 25 years has retired and Cheryle Wood will be taking this position.

I hope that the course superintendent reports that have appeared in The Georgian over the golfing season have helped the members understand and appreciate the efforts and expertise that goes into getting the course in prime shape during the golfing season and between the construction program. The questions that appeared were asked by the members.

Murray Kutyn is continuing in doing a great job as Chief Icemaker, construction of the new greens and being in charge of the landscaping and flowers

I thank the Board of Directors who have always been near to give me a hand, besides them having regular duties in their work place and committee

The overall strength of our club depends on effective and well organized committees and in this regard I thank all members, volunteers and sponsors who make our club a benefit to all.

Our communications to our members in the past have been a little lapsed in trying to get information to you. We feel The Georgian has not been the most effective way as some months the first weeks are not known. We will in the next few weeks have the manager post information in the lobby of events that may be of interest to you.

Your input is very valued and we will continue to ask for your support.

#### 8. Reports

a) Special Projects - Driving Range - John Heaslip

Special Projects Committee: John Heaslip, Ken Lunn, Pat White & Flo McKinley (see note at end of minutes)

MOTION: (Endorsed by B.O.D.)

That the Prince George Golf and Curling Club proceed with the sale of 2.78 acres of surplus land (D.L.8176) located between the eleventh fairway and the Pine Centre Shopping Mall to Kelfor Holdings, in the amount of \$910,000.

When the sale of the 2.78 acres has been completed, the \$910,000 shall be held in trust by the City solicitor until such time as the Prince George Golf and Curling Club takes possession of the Rotary Stadium Lands, 16.6 acres. Interest on the proceeds of the sale shall flow to the Prince George Golf and Curling Club until such time as it has possession of Rotary Stadium.

At this time the City of Prince George will sell the 16.6 acres known as Rotary Stadium to the Prince George Golf and Curling Club for the sum of \$1.00 and the \$910,000 shall be released to the City of Prince George.

In addition, the City of Prince George will provide the Prince George Golf and Curling Club with a \$110,000 interest free loan payable on a five year term. This will provide funding for the construction of the new driving range.

All survey, registration, real estate and legal fees shall be the responsibility of the City of Prince George.

MOVED by John Heaslip, SECONDED by Greg Ames.

#### Discussion to Motion

Q1: How will it be financed? Will we need a bank loan? (Chester Jeffrey)

A1: No, it is not likely. It will be financed with the term deposits of \$350,000 and assessments of \$160,000. The only financing may be a short term line of credit. Year one (1) will be tight but finances should be okay. (John Heaslip)

Q2: Will it be deeded? (Al Wells)

A2: Yes. (John Heaslip)

Q3: When will this occur? (Bob Dick)

A3: Junior soccer must relocate to Ospika field - possibly in the fall of 1996.

A4: The word possession in the motion is vague. Please read the motion again. (Bob Dick)

A4: (Read as requested) (John Heaslip)

#### Amendment to Motion:

Change the word "possession" in paragraph 2 to "title". (Bob Dick/Greg Ames)

#### Discussion to Amended Motion:

Q1: Why don't we push to make the City make a commitment (get an exact date)? (Tom Cole)

A1: If possession is possible in the Fall of 1996, we don't want title until Spring 1997, because interest will still accumulate - \$30,000 to \$40,000. (John Heaslip)

Q2: How did the tennis courts become a reality so quickly? (Tom Cole)

A2: The Tennis Club had a BC21 Grant. (Bob Dick)

A2A: This is an intricate negotiation with seven players involved. Junior soccer can't move until the SPCA and the Munro St. dump are relocated and more fields are built. (Bill McIvor)

Q3: Is this a contract? (Bob Cochrane)

A3: No. (John Heaslip)

Q4: Will this range replace Pine Valley? (Findlay Young)

A4: Don't know. (John Heaslip)

Q5: Has a BC21 Grant been considered for the range construction? (Evan Moore)

A5: Has not been yet, but may be investigated in the future. (John Heaslip)

O1: Could the courts be used as an indoor driving range? (Findlay Young)

A1: Perhaps. (Greg Ames)

Q2: Will court fee rates for members be lowered? (Richard Wilczek)

A2: The prices were lowered for non-members and no increases will occur for this year. There has been severe competition with the new UNBC facilities. We want to lure the players back with lower fees. There are other advantages to promote: Free parking, showers, court time and lockers. (Greg Ames)

MOTION: The Court Report be accepted as read (Greg Ames/Don Grantham) CARRIED

f) Green Committee - Ron Phillips (see note at end of minutes)

#### Questions:

Q1: The Tee Box mats on #8 and #14 have mud and grass coming through them. Can this be corrected? (Tom Cole)

A1: This will be passed on to the Course Superintendent. (Ron Phillips)

Q2: What is the purpose of the "Kirby" markers and what is the cost? (Bob Cochrane)

A2: They are intended to promote speed of play. They are on trial only. The whole course would cost \$12,000 to install. (Ron Phillips)

Q3: Why are they green? They are hard to see. (Bob Dick)

A3: They are meant to blend in as much as possible. They can be seen from 15 yards away and are placed every 25 yards. (Ron Phillips)

Q4: When the new Tec markers are installed will there be 5 markers - 3 for men and 2 for women? (Ken Dorosh)

A4: No, just 3 markers all 3 rated for men and the forward and middle markers rated for women. (Ron Magrath)

MOTION: The Green Committee Report be accepted as read (Ron Phillips/ Glen Bryant) CARRIED

## b) MOTION (September 1995 The Georgian)

The following motion has been received:

I would like to make a motion to the Board that the bylaws of the Prince George Golf & Curling Club Constitution be changed to reflect the following: That if a member is transferred, or taken ill or cannot continue using their membership for some reason, can then transfer his/her membership to their adult children.

Requires a 75% majority to pass (Betty-June Gair). Motion not signed by mover. Call for a mover and seconder from the floor. (Mary Niehaus/Kim Lancaster)

#### Discussion:

Q1: What is done at present? (Chester Jeffrey)

A2: A transfer to a spouse is okay. The membership privileges are available for children under 19 years or children under 25 still attending school. Once the membership can no longer be used, it is transferred to the Directors. (Bob Dick).

Q2: What does this encompass? (Blaine Black)

A2: The Directors hold the membership until it is sold to a new member. Any refund of membership owing to the original owner would then be paid. This is not applicable after 8 years. (Bob Dick)

Speak against: Ed Goodkey

- By purchasing a membership in the Society, you buy privileges to play for a period of time.

- It should not be transferrable.

- Where would the ongoing capital come from: New memberships generate revenue.

Speaking for: Russ Trenaman

- Transfer of memberships is not unusual in many organizations.

- The young people will perpetuate the Club.

Speaking for: Bob Cochrane

- There appears to be an inconsistency. Corporate memberships are transferrable while personal memberships are not.

Point of Clarification: Carol Tichelman

- When the corporate designate changes, as occurs regularly, a sizable fee is paid by the corporate member for the change.

Speaking against: John Heaslip

- The loss of revenue from future membership sales will have to be picked up by the general membership.

- This Club does not offer equity memberships.

Speaking against: Richard Wilczek

Comment - Bob Dick

Reminding the membership that this is a change to the constitution and requires a 75% majority.

MOTION: Constitutional Amendment. DEFEATED
