Until this time, the temporary greens are marked by a ground under repair stake on one and three are a free drop no closer to the hole. Please take relief from these areas.

Ball marks on our greens are a problem. Please repair your ball marks on the greens. The proper way to repair a ball mark is to push the grass in from the sides and all around the ball mark. Lifting the center of the ball mark only exposes the roots which leads to a small dead spot which takes a lot longer to heal.

## Notice of Motion

Notice is hereby given to the members of the Prince George Golf and Curling Club, that there will be placed before the Annual General Meeting in September 1997, a motion to amend the Constitution and Bylaws of the Society to add a new category of membership, namely that of "INACTIVE."

The reason for this proposed new membership category is:

According to our Constitution and Bylaws, there are only three classes of membership in the Prince George Golf and Curling Club: regular, corporate and life.

Although members have been allowed to put their membership in a "dormant" category, there is no such category in the Society's constitution to accommodate them. These "dormant" members no longer belong, nor have any privileges in the Society or Club. They are in effect "General Public."

Your Board of Directors is proposing to create a new category called "INACTIVE" membership. If the club members agree to the establishment of this new membership status, all current "dormant" members who want to, will have the opportunity to be brought back into the Club.

Over the past number of years, since 1987, there have been a number of changes to bylaws and policies of the Society (Club). It is proposed that these changes be ratified at the AGM. Copies of the "new" constitution and bylaws are available at the front desk, but will not be published in the *Georgian* prior to the AGM.

### INACTIVE MEMBERSHIP

- An "INACTIVE MEMBER" will refer to any member who currently holds a membership in the Prince George Golf and

Curling Club, and chooses not to pay the full capital assessment as set by the Board of Directors.

- An "INACTIVE MEMBER" will pay a yearly fee which will be set by the Board of Directors (currently \$125.00).

- The fee must be paid in advance by April 30th of each year to cover the following 12 month period. Those 90 days in arrears will be deemed to have resigned their membership in the Society.

- Those who change their membership to INACTIVE will prepay a pro-rated fee to cover fees to the April 30th date.

- There will be a re-activation fee paid when an "INACTIVE MEMBER" chooses to re-activate their membership. This fee will be set from time to time by the Board of Directors.

- Members will be required to pay all indebtedness to the Club prior to approval as a INACTIVE MEMBER.

- An INACTIVE MEMBER would not have charging privileges, booking privileges or discounted fees as regular or corporate members now enjoy.

- "Dormant" members will have until April 30, 1998 to choose to "re-join" the club as Inactive or active members. The "INACTIVE" fee must be paid prior to May 1, 1998 in order that a membership be placed in the "INACTIVE" category. "Dormant" members who fail to respond by April 30, 1998 will be removed from membership of the Society.

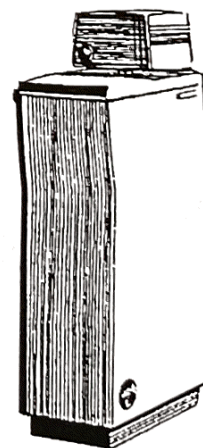

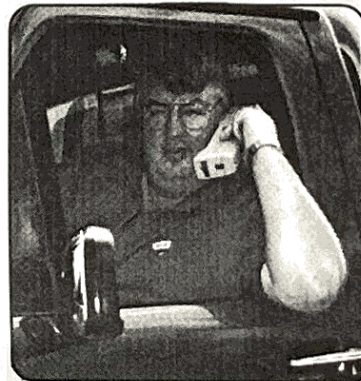

## Seniors Curling

Are you 50 years and over? Like to Curl? Female or Male we welcome you into our Tuesday or Thursday 1:00 pm curling league. We elect our own executive and run our own events. The main purpose of the leagues is to have fun curling, socializing after curling or at a number of special events held throughout the year. It makes the winter shorter and more enjoyable.

The league is comprised of good curlers, average curlers and beginners. The Tuesday and Thursday leagues have separate schedules and different teams which enable you to curl once or twice a week with different people. Last year there were 22 teams curling Tuesdays, which is the maximum, and 12 teams on Thursday. It would be great to expand on Thursdays to at least 16 teams.

If you have curled in prior years and haven't thrown a rock for years, come on out. If you are a good curler you may be able to skip. If you haven't curled and would like to join, we welcome you. Skips are selected and they then choose their 3rds in rotation. 2nd and leads will be drawn from a hat.

We begin curling in October and finish in early April. The cost this year is \$130 for non club members and \$100 for club members. If you want to curl both days there is a substantial discount. Leagues cost money to operate mainly for prizes and in previous years, money was raised by hockey pools. Hockey pools will be eliminated and replaced by a registration fee which will not be more than \$10.

Don't worry if you usually have a winter holiday, many of us do. With a little luck, a spare will fill in for you.

To register, inquire at the front office of the Club in early September. See you on the ice.

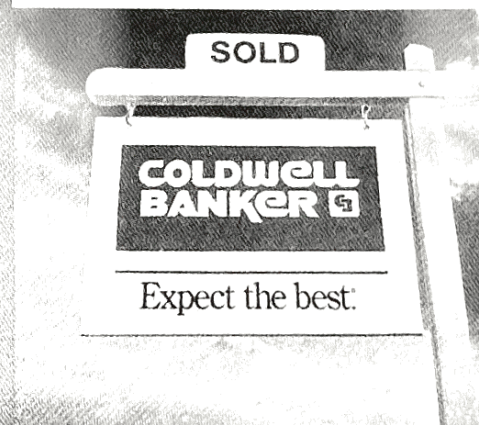
